Role of the Day-Care Project Sponsor

The main priority in 2010 is the building and furnishing of the nursery "Growing Flower". Function of a Music Camp Project Sponsor

The next Music Camp will be held in March 2010. However, the number of those children able to attend the Camp is dependent upon sponsor donations.

Our vision is to hold the Music Camp twice a year, for 14 days at a time.

Through your project sponsorship you can secure the funding of long-term projects and the future of the children that we support. Longevity is the most important aspect of working with the disadvantaged, to bring about lasting change.

You determine your contribution (from 24 € per year).

A single donation or regular donations will support:

Donations and Taxes

Sponsorships payments are considered as donations and are therefore tax deductible. At the beginning of the financial year you will receive a sponsorship certificate detailing all your contributions for the previous year. All members of the charity are volunteers. There are no administrative costs. Expenses such as postage and shipping, telephone charges and travel expenses are all privately financed, so that 100% of all donations go to the children in Nepal.
